In light of ongoing concerns regarding the COVID-19 pandemic, public attendance at Des Peres Board of Adjustment meetings has been temporarily limited in compliance with St. Louis County Executive Order #11 issued by the Department of Health. The City of Des Peres has made arrangements to livestream Board of Adjustment Meetings during this pandemic to allow the general public to observe meetings in real-time. The Board will consider the following items:

- 1) A request by Maris Home Improvements, on behalf of Heather and Robert Luljak, property owners at 12324 Ballas Estates Drive, to construct a new deck within the same footprint that would encroach 18' in to the rear yard setback, establishing a 22' rear yard setback. Section 404.020 B.4 requires a 40' rear yard setback in the D-Residential Zoning District.
- 2) A request by Fred Bueler, Jr., property owner, at 2410 Fairoyal Drive to construct an uncovered deck that would encroach 4.04' into the side yard setback and 13.15' into the rear yard setback, establishing a 5.96' side yard setback and 26.85' rear yard setback, respectively. Section 404.005 B. 2 requires a 10' side yard setback and a 40' rear yard setback in the D-Residential Zoning District.
