MINUTES BOARD OF ALDERMEN MARCH 8, 2021 DES PERES GOVERNMENT CENTER

The regular meeting of the Board of Aldermen of the City of Des Peres, Missouri was held at the Des Peres Government Center, 12325 Manchester Road 63131, commencing at 7:00 P.M. on Monday, March 8, 2021.

ROLL CALL

The City Clerk took roll with the following elected officials present: Alderman Barrett, Alderman Sansone, Alderman Pound, Alderman Kleinschmidt, Alderman Concagh and Alderman Fitzpatrick. Mayor Becker was also present.

Staff members present included the City Administrator, Assistant City Administrator, City Clerk, City Attorney, Director of Finance, Director of Parks & Recreation, Director of Public Safety and Director of Public Works.

Mayor Becker stated that due to COVID health restrictions, remote attendance at the meeting is permitted. For the record, Alderman Kleinschmidt and Alderman Sansone attended the meeting remotely.

Joel Montgomery with Montgomery Property Management attended the meeting via Zoom and asked if anyone had any questions. Mayor Becker asked what the timeline would be on this project. Mr. Montgomery stated that this project would be done towards the end of summer.

Unfinished Business - NONE

1. **B21-2909** An Ordinance Amending the Master Development Plan for Des Peres Pointe and Issuing a Conditional Use Permit for Chipotle Mexican Grill for Operation of a Restaurant at 13307 Manchester Road in the Des Peres Pointe Shopping Center

Alderman Barrett Read Bill 21-2909 for the second time.

Alderman Barrett made a motion, seconded by Alderman Fitzpatrick to approve Bill 21-2909. A roll call vote was taken with the following results: Alderman Barrett, "AYE", Alderman Concagh, "AYE", Alderman Fitzpatrick, "AYE", Alderman Kleinschmidt, "AYE", Alderman Pound, "AYE", Alderman Sansone, "AYE"; Motion passed 6-0.

2. **B21-2910** An Ordinance Authorizing a Contract with the Missouri Highways and Transportation Commission Relating to Reconstruction of Sidewalks and Curbs and the Resurfacing of Lindenmann Road

Alderman Pound Read Bill 21-2910 for the second time.

Alderman Pound made a motion, seconded by Alderman Fitzpatrick to approve Bill 21-2910. A roll call vote was taken with the following results: Alderman Barrett, "AYE", Alderman Concagh, "AYE", Alderman Fitzpatrick, "AYE", Alderman Kleinschmidt, "AYE", Alderman Pound, "AYE", Alderman Sansone, "AYE"; Motion passed 6-0.

New Business

1. **R21-3462** Authorizing a Contract for Purchase of Sales Tax Interruption Insurance with Lloyds of London With Insurance Coverage of \$3,000,000 for the Year Commencing March 9, 2021.

Alderman Kleinschmidt moved this item down from the Consent Agenda for discussion.

Alderman Kleinschmidt asked if this contract would be paying for anything realistic. City Administrator stated the following:

This contract authorizes placement of Sales Tax Interruption Insurance for a 12-month period with Lloyds of London at an annual premium of \$26,616.00 for \$3,000,000.00 in coverage for lost income at West County Center, Schnucks, Dierbergs or Sam's due to a fire or natural disaster. We budgeted \$35,000 for this coverage in 2021. Last year the city paid \$29,500 for \$4.5 million in coverage with a \$10,000 deductible.

The deductible proposed for the contract is not a set dollar amount but rather a 7-day waiting period after an occurrence. To put that into dollar perspective, a 7-day waiting period at WCC would be \$70,000 based on average day's sales tax – higher if the loss occurs in peak months like back-to-school sales or the Christmas Holidays.

Lloyds and Landmark both have agreed to hold their quotes open until Tuesday, March 9th to allow time for the Board of Aldermen to consider the options.

Staff recommended to award a contract to Lloyds for the \$3.0 million in coverage at a cost of \$26,116 and to forego the option to include terrorism coverage.

Alderman Barrett made a motion, seconded by Alderman Fitzpatrick to approve the proposed insurance coverage. A roll call vote was taken with the following results: Alderman Barrett, "AYE", Alderman Concagh, "AYE", Alderman Fitzpatrick, "AYE", Alderman Kleinschmidt, "NAY", Alderman Pound, "AYE", Alderman Sansone, "NAY"; Motion passed 4-2.

Temporary Exterior Sales Permits

Staff has received an inquiry from Circa Pub & Grill about continuing their outdoor concerts on some weekends this summer or until interior dining restrictions are lifted. The owner has not formally applied for a Temporary Exterior Sales, Display or Storage permit which the city has used in the past for similar requests. That permit requires a public hearing and action by the Board of Aldermen.

Circa Pub & Grill previously hosted concerts due to the Emergency Orders of the Mayor to suspend some restrictions on outdoor dining and/or outdoor events during the pandemic. That order is due to expire March 31, 2021 unless extended.

For the record, Mayor Becker stated he would allow Circa Pub & Grill to proceed with their request of having outdoor concerts on weekends this summer or until interior dining restrictions are lifted. Mayor Becker later requested that staff explore the concept of adopting uniform regulations that would allow for special events under certain conditions with final approval delegated to staff as an administrative function.
