ROLL CALL

Commissioner Chair Beermann opened the meeting. Administrative Assistant Llorián commenced with the roll call. The entire commission was present.

HEAR CITIZENS

Matt McGrath introduced himself to the commission.

APPROVAL OF MINUTES

Commissioner Ashcraft made a motion to approve the minutes of the June 3, 2019, meeting. Commissioner Zimmerman seconded the motion, and it passed unanimously.

AMENDMENT TO THE AGENDA

Commissioner Ashcraft made a motion to amend the agenda to include the election a chairperson of the Public Safety Commission in new business. Commissioner Lund seconded the motion, and it passed unanimously.

ALDERMANIC REPORT

Alderman Barrett introduced himself. He stated that the Planning & Zoning Commission voted on a second reading regarding medicinal marijuana legislation. He concluded that they approved the tennis court project.

BUDGET

Chief Hall stated that the 2019 budget is continuing on track. He stated that Captain Quinn was able to petition Chevrolet for the repetitive repairs on the 2017 Chevy Tahoe that is assigned to the supervisors and Chevrolet did reimburse the department for some of the expenses. Chief Hall advised that all accounts have leveled off for the midpoint of the year and overtime has remained on track.

NEW BUSINESS

Election of Chairperson for Public Safety Commission

Commissioner Ashcraft made a motion to elect Commissioner Beermann as chairperson for the Public Safety Commission. Commissioner Zimmerman seconded the motion, and it passed unanimously.

OLD BUSINESS

Commission on Law Enforcement International (CALEA) Update

Chief Hall introduced Lt. Severs as the new Support Services Lieutenant and CALEA manager due to Lt. Willoughby being out on medical leave.

New Hires

Chief Hall stated that Det. Koppel will be retiring from the department on July 13th, 2019. He stated that the department is running an advertisement for police officers and that the advertisement is open until the end of July. The department will then schedule the preliminary interviews with the candidates.

New Electronic Sign

Chief Hall presented the commission with a department roster with personnel and current assignments.


